

## **THE ENERGY EFFICIENCY ACT**

### **Regulations made by the Minister under section 23 of the Energy Efficiency Act**

1. These regulations may be cited as the Energy Efficiency (Registration of Energy Auditors) Regulations 2016.

2. In these regulations –

“energy auditor” includes an energy audit firm.

3. (1) No individual or firm shall practice energy auditing in Mauritius unless that individual or firm is registered as an energy auditor with the Office.

(2) Any individual or firm wishing to be registered as an energy auditor shall make an application to the Office in the appropriate form set out in the First Schedule.

(3) The Office may require an applicant to furnish such other information or produce such additional document as the Office may consider necessary.

4. (1) The Office may register an applicant under regulation 3 where it is satisfied that the applicant –

(a) in the case of an individual, is certified by any one of the certification bodies specified in the Second Schedule or as the Office may approve; or

(b) in the case of a firm –

(i) is certified by any one of the certification bodies specified in the Second Schedule or as the Office may approve; or

(ii) employs an energy auditor who is registered with the Office under paragraph (2).

(2) Where the Office grants an application made under regulation 3, it shall, on payment of the appropriate fee specified in the Third Schedule, register the applicant and issue a certificate of registration to the applicant.

(3) Where the Office refuses an application made under regulation 3, it shall notify the applicant in writing, stating the reasons of the refusal.

(4) The determination of the Office in relation to an application shall be communicated to the applicant not later than 30 days from –

- (a) the date of the application; or
- (b) the date of receipt, by the Office, of such additional information or document as the Office may require under regulation 3(3),

whichever is the later.

5. (1) A certificate of registration issued under regulations 4(2), 6(5) and 8(3) –

- (a) shall be valid for a period of 5 years; and
- (b) may, subject to paragraph (2), be renewed for further periods of 5 years.

(2) An energy auditor shall, during the 5-year period of validity of his registration, be required to carry out an energy audit to a level of detail of Level 2, for all objects, of at least one non-residential building, each with an average yearly energy consumption of at least 5 tonnes of oil equivalent.

(3) An energy auditor who, prior to the coming into operation of these regulations, was initially registered for a period of 2 years, shall, on the coming into operation of these regulations, be deemed to have been registered for another period of 3 years from the expiry of the initial period of 2 years of registration.

6. (1) Subject to paragraph (2A), an energy auditor may, not later than 30 days before the expiry of his registration, make an application to the Office for the renewal of that registration.

(2) The application for renewal of registration shall be made in the appropriate form set out in the First Schedule.

(2A) Where an energy auditor fails to meet the requirements specified in regulation 5(2) –

(a) he shall not qualify for the renewal of his registration;

(b) he may, not later than 30 days before the expiry of his registration, make a request, in writing to the Office, to extend his registration to enable him to meet the requirements specified in regulation 5(2).

(2B) Where the Office grants a request made under paragraph (2A), it shall, on payment of the appropriate fee specified in the Third Schedule, extend the registration of the energy auditor by such period, not exceeding one year, as it may determine and issue a new certificate of registration to him.

(2C) An extension under paragraph (2B) may be granted by the Office only once within a period of 5 years.

(3) The Office may require the applicant to furnish such other information or produce such additional document as it may consider necessary for the purpose of determining the application for renewal or request for extension of registration.

(4) The Office may renew the registration of the applicant where it is satisfied that the applicant meets the criteria set out in regulations 4(1) and 5(2).

(5) Where the Office grants an application made to it under paragraph (1), it shall, on payment of the appropriate fee specified in the Third Schedule, renew the registration of the applicant and issue a new certificate of registration to the applicant.

(6) Where the Office refuses an application made to it under paragraph (1) or a request for extension made under paragraph (2A), it shall notify the applicant in writing, stating the reasons of the refusal.

(7) The determination of the Office in relation to an application made to it under paragraph (1) or a request for extension made under paragraph (2A) shall be communicated to the applicant not later than 30 days from –

- (a) the date of the application or request; or
- (b) the date of receipt, by the Office, of such additional information or document as the Office may require under paragraph (3),

whichever is the later.

(8) In this regulation –

“Level 2”, in relation to the level of detail of an energy audit, has the same meaning as in the Energy Efficiency (Energy Consumer and Energy Audit) Regulations 2017.

7. (1) Where a certificate is lost, damaged or destroyed, the energy auditor shall, as soon as possible, report such loss, damage or destruction to the Office and apply for the issue of a duplicate certificate of registration.

(2) Where an application is made under paragraph (1), the Office shall, on payment of the appropriate fee specified in the Third Schedule, issue a duplicate certificate of registration to the energy auditor.

8. (1) The Office shall deregister an energy auditor where –

- (a) the energy auditor makes a request to the Office, in writing, to that effect;
- (b) the energy auditor no longer meets the criteria set out in regulation 4(1);
- (c) the Office becomes aware that the application for registration or renewal of registration, as the case may be, was made on the basis of false information;

- (d) the registration of the energy auditor is not renewed;  
or
- (e) no application for renewal or request for extension is submitted by the energy auditor before the expiry date of his registration.

(1A) For the purpose of paragraph (1)(b), where an energy auditor no longer meets the criteria set out in regulation 4(1), he shall, within 10 days from the date of such non-compliance, inform the Office in writing.

(2) Subject to paragraph (3), regulation 3 shall apply to an energy auditor who has been deregistered under paragraph (1) and wishes to be registered with the Office anew on payment of the appropriate fee specified in the Third Schedule.

(3) (a) Where an energy auditor has been deregistered under paragraph (1), the Office may –

- (i) require the energy auditor to furnish such information or document as it may determine; and
- (ii) on payment by the energy auditor of the appropriate fee specified in the Third Schedule,

cause the energy auditor to be registered anew.

(b) Where the energy auditor is registered anew under subparagraph (a), the Office shall issue to him a certificate of registration on such conditions as it may determine.

(4) Any person who –

- (a) knowingly submits false information to the Office; or
- (b) otherwise contravenes these regulations,

shall commit an offence and shall, on conviction, be liable to a fine not exceeding 100,000 rupees.

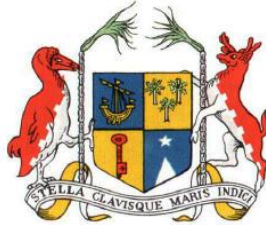
